Potential users

All individuals with at least one record in one of the public sector's main registries, meaning anyone who has been issued a tax or insurance or identity number or has a record at the Citizen's Registry

Personal Number beneficiaries

Those who are legal guardians of people in the above two capacities

Who benefits the most

Users of digital services

Individuals facing problems of identification in the digital world due to mistakes or discrepancies of their data in the registries

Citizens in myInfo...

1. View:

- the results of their record matching in the registries

- Their personal data the way it is recorded in related records

- Errors or discrepancies in the records that need to be fixed or updated

- Indicative duplicates

- Their Personal Number

2. Confirm their matching and personal data, in case of agreement. Then, automatically:

- All matched registry records are updated with the data from the source registry

- From then on, each change that occurs in the source registry is automatically forwarded to the rest

3. Submit their objection if they disagree with the results of their matching.
4. May:
 - ✓ Confirm the personal and matching information for their underage children or people to whom they act as legal guardians

Data subject to confirmation

1. Personal data (surname, first name, father's and mother's name, birth date) from the Citizen Registry as stated by law
2. Identifiers of the matching records in the following registries:
 - Citizen registry
 - Tax Registry
 - Social Insurance Registry
 - Police Registry
3. After confirmation, each connected registry is notified of the necessary updates to the citizen's personal data records
4. Updates to personal data in the Citizen Registry are only allowed to the local municipal office under the procedures in force.

Access points

Via the Greek public administration portal

Login to myInfo @ gov.gr

1. Enter your taxinet credentials and press “Σύνδεση»
2. Enter the OTP (one-time password) you receive to your cell phone. OTP remains valid for 5 minutes.

* Don't forget to preregister your contact information to the National Communication Registry (EMEp)

View A: Identification

After your login you may see:

1. your personal number, if it is issued
2. your name information and date of birth from the nominated registry
3. your identification numbers to the primary public sector's registries: Municipal, Tax, Social Insurance, Police, Third Countries Citizens (coming in next version)

The “not registered” statement

When checking the “not registered” option

- you either confirm that there is indeed no registration of you to one or more registries or that the record found and matched in the specific registry does not apply to you.

Scenario I: Verification of all fields

After submitting your verification



Your Personal Number is automatically issued

All matched secondary registries are informed of the necessary updates in your records according to the source registry

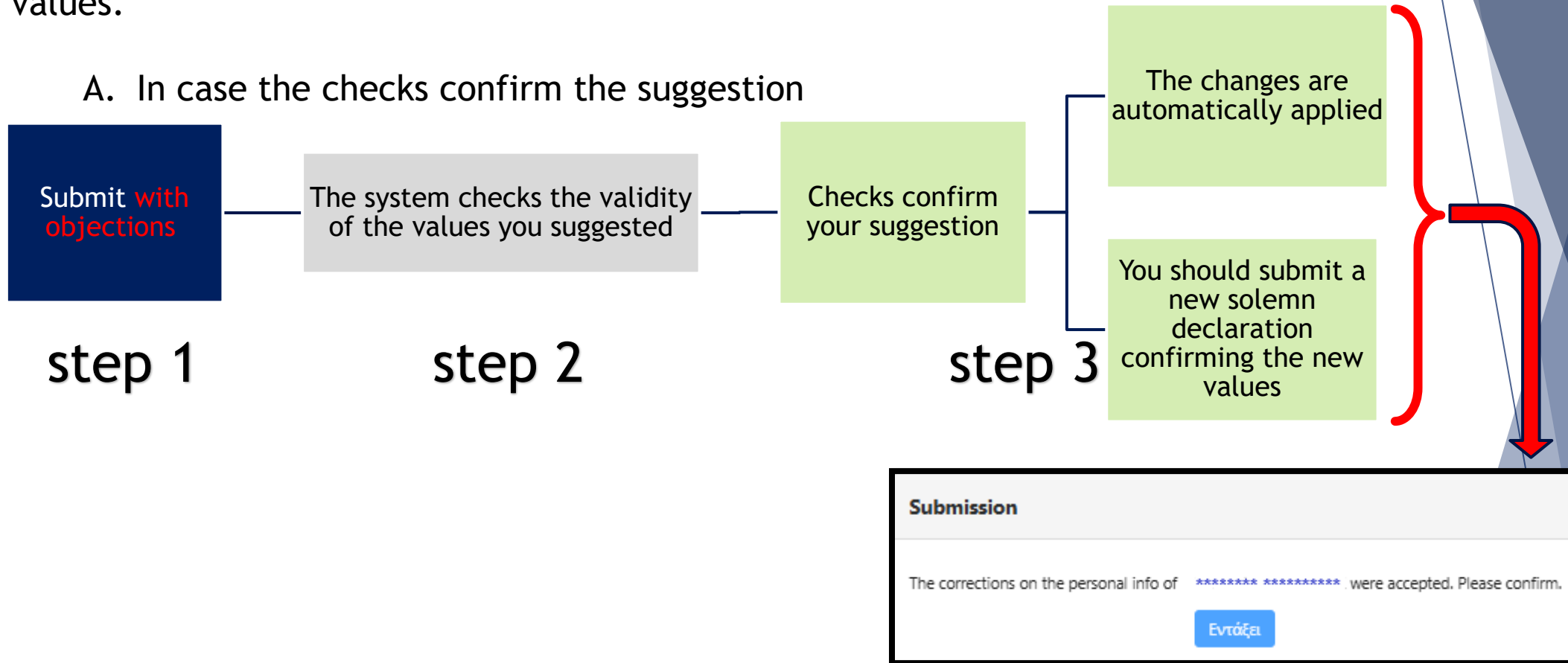
You may repeat the process for the non-adult members of your family

From then on, each change that occurs in a source registry is automatically propagated to the rest

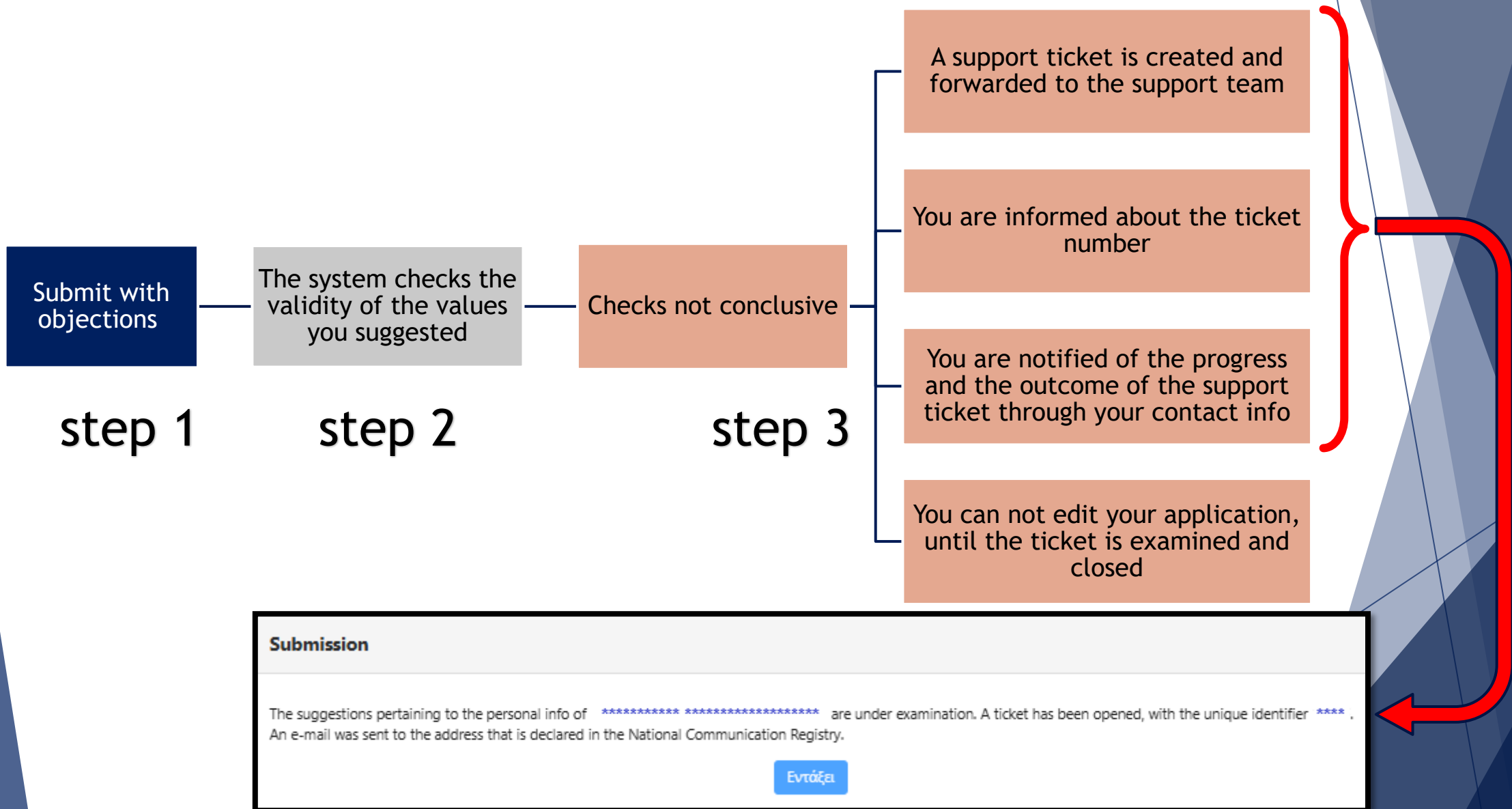
Scenario II: Submitting with objections

In case you submit with objections, the system executes validity checks for the suggested values.

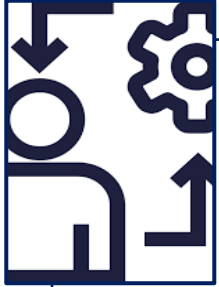
A. In case the checks confirm the suggestion



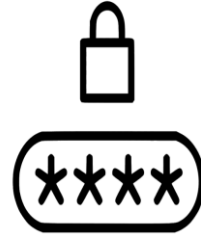
Scenario II: Submitting with objections



After submitting



View your records in all matched registries



The personal number for you is automatically issued and you may repeat the procedure for the protected members of your family



You may edit or print your declaration



The last declaration date is recorded by the system

Issuing your personal number

The PA is automatically issued:

- To individuals who have already completed the process of verifying their personal details, but the issuance of the PA has not yet been finalized.
- To individuals whose surname, first name, father's name, mother's name, and date of birth, as shown in the special electronic application "myInfo", match the corresponding details in their registration in the Tax Registry.
- To individuals born after the Presidential Decree 40/2025, provided that the process of assigning a Tax Identification Number has been completed.

Remember that the Personal Number is unique per person and cannot be modified

The personal number is composed of:

- 3 digits (letters or numbers) and
- the 9 digits of your tax registration number

Total: 12 digits

Issuing your personal number

A success message appears on the screen. You are also notified by email or sms.

Issue Personal Number

You were granted the Personal Number AB *****

An e-mail was sent to the address that is declared in the National Communication Registry.

Acting on behalf of the protected members of your family

Preconditions

- ▶ As guardian you should first confirm your own data
- ▶ The protected member in underage
- ▶ The guardian and the protected member belong to the same or related family record at the Citizen Registry
- ▶ In order to issue a personal number, the protected member must own a tax registration number

Selecting a protected member

After you verify your data, you may do the same for the underage members of your family.

There are two ways to complete this action

1st way:

- Click on the button  
- Fill in the protected member's social insurance number and press Enter

2nd way:

If you have already verified your data, at your next login you click on the displayed pop up

Fill in the Social Insurance Number of the minor

Press “Enter”

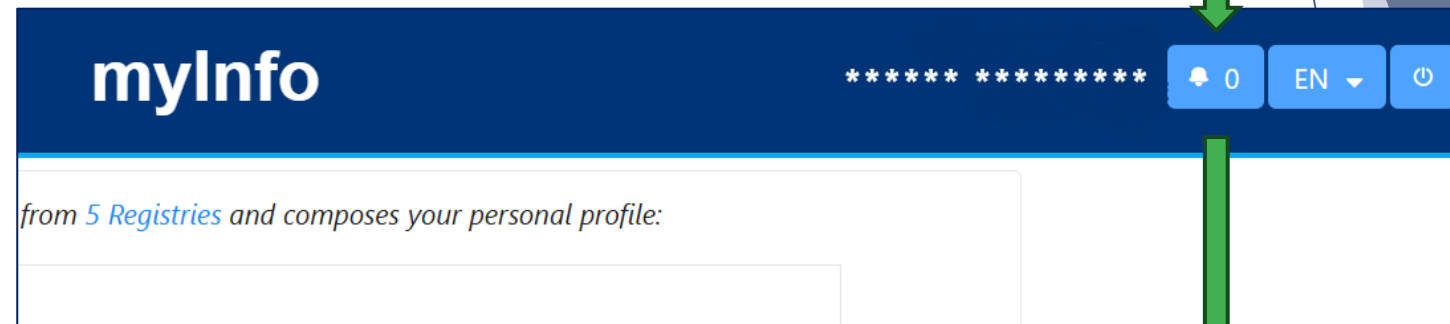
Protected member's data confirmation

Review the validity of the protected member's data and follow the same [procedure](#) to submit your agreement or objection on its behalf.

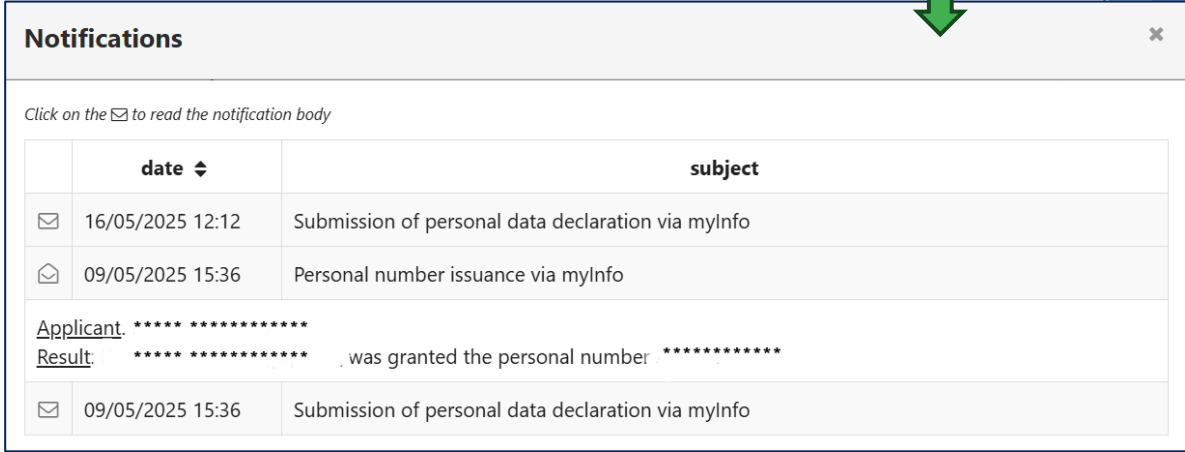
The solemn declaration is formed according to the data the guardian declares and then submits on behalf of the protected member.

Notifications

For each action concerning your data, the system creates a corresponding notification. To display those notifications, you can select the button , placed at the top right part of the screen
